GENERAL INFORMATION

1. **Tour Cost: \$950.00 Per Person - Quint Occupancy (5 people in 1 room).** The cost of the Orlando, FL tour is based on a minimum of 90 and maximum of 100 paid participants. The price is subject to change if there are less or more than 90-100 paid participants or if changes occur in the fuel surcharges. Surcharges will be added if the stated numbers are not met.
2. A non-refundable deposit of \$50.00 is required by **May 28, 2010**, a second payment of \$225.00 due **July 2, 2010**, a third payment of \$225.00 due on **September 24, 2010**, a fourth payment of \$225.00 due on **November 26, 2010** and the approximate final payment of \$225.00 due on **January 28, 2011**.
 - a. **LAST PAYMENT IS APPROXIMATE based on final group numbers – Director will let students know of final payment amount on December 1, 2010.**
 - *** Payment may be paid with Visa/MasterCard and will be charged a 3% service fee.

 - ***Payments by check should be made out to Bob Rogers Travel.
 - ***Personal and/or business checks will not be accepted 28 days or less prior to the tour.
3. A service fee of \$25.00 is assessed for NSF checks or stop payment checks. Future payments would have to be in form of cashiers check or money order.

This price is based on all students staying in a quint room. Other room arrangements will result in a price change of \$974.00/person (based on quad occupancy), \$1,066.00/person (based on triple occupancy), \$1,098.00/person (based on double occupancy) & \$1,344.00/person (based on single occupancy)

CANCELLATION POLICY:

- *All cancellations must be in writing to Bob Rogers Travel. The due date of the postmark is the date used to determine the amount of the cancellation fee.
- * Individual cancellations, for any reason, will be subject to the following fees to be retained by Bob Rogers Travel:
From date deposit was received until 76 days before the tour - \$100.00/person plus unrecoverable fees
75-45 days prior to departure - Half quad cost/person
45- 0 days prior to departure – NO REFUNDS
- * If the directors cancel the tour or change the tour date, a refund, less a \$50.00/pp processing fee plus any non-refundable fees retained by our suppliers, will be given.
- * If Bob Rogers Travel cancels the tour, a full refund will be given.
